**RELEASE OF LIABILITY AND HOLD HARMLESS**

**READ BEFORE SIGNING**

IN CONSIDERATION OF me being allowed to coach and participate in any way in New York Elite F.C. related programs, events and activities, the undersigned acknowledges, appreciates, and agrees that:

The risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19) to me from New York Elite F.C. (hereinafter "NYEFC") programs, events and activities are significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and,

1. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation in the programs, events and activities; and,
2. On behalf of my/our heirs, assigns, personal representatives and next of kin willingly agree to comply with NYEFC's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my readiness for participation in the program/event/activity itself, I will remove myself from the participation and bring such attention of the nearest official immediately; and,
3. I, and on behalf of my/our heirs, assigns, personal representatives and next of kin understand and acknowledge that the COVID-19 virus is extremely contagious and that the mere physical presence at NYEFC programs, events and activities could increase the risk of contracting the disease. It is understood and acknowledged that I must cooperate to comply with preventative measures and health guidelines, including but not limited to measures and guidelines set forth by NYEFC, the New York State Department of Health (NYSDOH) and the Center for Disease Control and Prevention.
4. I and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS NYEFC; its directors, officers, coaches, officials, agents, employees, volunteers, independent contractors, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the events ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property incident to my involvement or participation in these programs, events and activities, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
5. I, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, events and activities, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.
